MINUTES OF THE ROSEAU RIVER WATERSHED DISTRICT BOARD OF MANAGERS MEETING HELD SEPTEMBER 10, 2019

OATH OF OFFICE: Manager Wensloff took his oath of office.

ORDER: Chairman Jason Braaten called the meeting to order at 8:00 a.m. and led the Pledge of Allegiance and Manager Wensloff took the oath of office.

<u>MANAGERS PRESENT</u>: LeRoy Carriere, Carter Diesen, Cody Schmalz, Tony Wensloff, and Jason Braaten

STAFF PRESENT: Administrator Halstensgard and Specialist McCormack

OTHERS PRESENT: There were no other attendees.

DELEGATIONS PRESENT: none

AGENDA: A motion was made by Manager Wensloff and seconded by Manager Carriere to approve the agenda. The motion carried unanimously.

CONSENT AGENDA:

A **motion** to approve the Consent Agenda was made by Manager Schmalz and seconded by Manager Wensloff. The motion carried unanimously. Adoption of the Consent Agenda included approving the August 7, 2019 minutes, the Treasurer's Report as handed out, manager and employee expense vouchers, and permit #19-27 (T. Brateng).

NEW BUSINESS:

The Board discussed certificate of deposits that are up for renewal. The discussion focused on interest rates and looking at banks outside of the district for investing. A **motion** was made by Manager Schmalz, seconded by Manager Carriere, to authorize Manager Diesen as the Treasurer to invest funds for the best rate available keeping in mind the objectives of the District. Motion carried unanimously.

Administrator Halstensgard discussed a proposal from Noah & Associates Inc. to complete a salary survey report and provide recommendations for wage adjustments for a three year term. After discussion, the board recommended asking the RRWMB if they are interested in cost sharing with districts that want to have a survey done for their district. Manager Braaten and Administrator Halstensgard will bring it to the RRWMB at their next meeting.

PERMITS: #19-26 (MNDNR) Department of Forestry submitted an application to install a series of new culverts and crossings in the ROW of The Great Northern Transmission Line. A **motion** was made by Manager Wensloff to approve permit #19-26. Manager Diesen seconded the motion which passed unanimously.

Budget Hearing:

At 8:30 am, Manager Diesen made a **motion** to open the budget hearing. The motion was seconded by Manager Carriere and passed unanimously. The RRWD did not receive any public comment regarding the budget. Manager Wensloff made a **motion** to close the public hearing, it was seconded by Manager Schmalz, and carried unanimously.

Manager Carriere made a **motion** to adopt the Administrative Budget for 2020. The motion was seconded by Manager Wensloff and passed unanimously.

The board was presented with the attached ditch levy resolution. A **motion** was made by Manager Wensloff, seconded by Manager Carriere to adopt the resolution as presented. The motion carried unanimously.

The board was presented with attached Red River Water Management Board resolution. A **motion** was made by Manager Wensloff, seconded by Manager Schmalz to adopt the resolution as presented. The motion carried unanimously.

PROJECT UPDATES:

Whitney Lake:

- Administrator Halstensgard reminded everyone of the open house scheduled from 4:30 6:30 on September 19th at the RRWD office. The open house will have information available on both the Whitney Lake project and the RRWD WRAPS.
- Chairman Braaten recused himself from the following discussion and Manager Wensloff chaired this portion of the meeting. An update was given on the CD 16 Improvement petition and the board was presented with a contract for the viewer's services. A motion was made by Manager Diesen and seconded by Manager Schmalz to accept and sign the viewer's contract. Motion carried with Manager Braaten abstaining. The meeting was turned back over to Chairman Braaten.

Roseau Lake:

• Engineer Dalager updated the board on the status of the project and noted that legal survey work needs to be done before legal descriptions can be drafted. this work is an important step before any land purchase can be completed. Engineer Dalager suggested Pribula Engineering for the survey work. The board had no issues with moving forward with this work.

Beltrami Island State Forest:

 After board discussion, Manager Wensloff made a motion not to move forward with the Houston Engineering proposal to model various conditions in CD 23. Manager Carriere seconded the motion which passed unanimously.

OLD BUSINESS:

CD 8 CWF Grant: Manager Wensloff recused himself from the board for this discussion.
The Halverson Sand & Gravel invoices for four side water inlets in accordance with the
contract with Wensloff Farms were presented to the board for payment. A motion was
made by Manager Carriere, seconded by Manager Schmalz and carried with Manager
Wensloff abstaining.

WHEREAS, the Roseau River Watershed District is a member of the Red River Watershed Management Board and pursuant to a resolution duly adopted, the Board of Managers executed a Joint Powers Agreement, and

WHEREAS, the resolution adopted by the Red River Watershed Management Board under the date of July 16, 2019, said Management Board, pursuant to the provision of Chapter 162, Section 1, 1976 Session Laws, and in accordance with the provisions of the Joint Powers Agreement, did direct this Watershed District to levy an ad valor em tax in the amount of .0003627 percent of the estimated market value. This levy to be made on all taxable property within their district in accordance with the provisions of Minnesota 1976 Sessions Law, Chapter 162, Section 1; as amended by laws of 1982, Chapter 474, Section 1; Laws 1983, Chapter 338; and laws of 1989 First Special Session, Chapter 1, Article 5, Section 45 and

WHEREAS: the Board of Managers of the Roseau River Watershed District are desirous of cooperation and fulfilling this obligation,

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF MANAGERS OF THE ROSEAU RIVER WATERSHED DISTRICT:

That the Roseau River Watershed District does hereby levy and ad valor em tax in the amount of .0003627 cent of the estimated market value of all taxable property within this district and within the counties set forth in cnapter 162, 1976 Session Laws.

That said levy shall be for the year 2019 and shall be collectible with the taxes recovered in the year 2020.

That the County Auditor of the County of Roseau, Kittson, Marshall, Beltrami, and Lake of the Woods shall make said levy in accordance with the provisions of the Minnesota Watershed Act, Chapter 112, chapter 162 (1976) the Joint Powers Agreement and Legislative direction.

That all proceeds of said levy shall be forwarded by the County Auditor of the County of Roseau, Kittson, Marshall, Beltrami, and Lake of the Woods to the Treasurer of the Roseau River Watershed District.

That the Treasurer of the Roseau River Watershed District shall retain one half of the proceeds of said levy, and the proceeds from the remaining on half shall be transmitted to Robert L Sip, Executive Director, Red River Watershed Management Board, 11 5th Avenue East, Suite B, Ada, MN 56510 and shall be credited to the general fund of the Red River Watershed Management Board."
